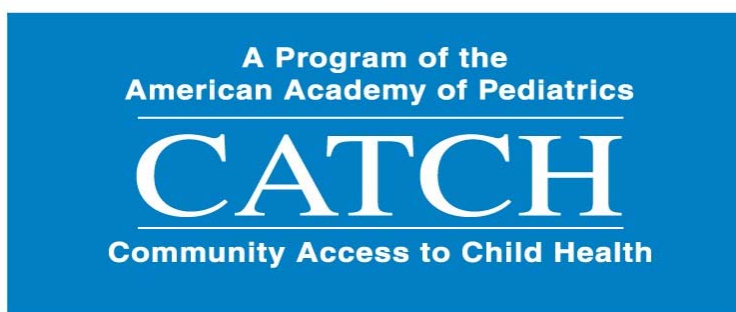

Program Goals

The Community Access to Child Health (CATCH) Resident Funds program supports pediatric residents in the planning and/or implementation of innovative, community-based initiatives that increase children's access to medical homes* or specific health services not otherwise available. Grants of up to \$3,000 are awarded twice each year on a competitive basis for residents to address the needs of children in their communities. These CATCH projects should lead to programs that can be replicated in other communities. Resident CATCH projects must include planning activities or demonstrate completed planning activities, and may include implementation activities.

A pediatric resident must lead the project and be significantly involved in proposal development and project activities. Residents are eligible to apply only if you are graduating from residency in or after June 2011 (for most Categorical Pediatrics Residents this would be PGY-1 and PGY-2 residents only). Please contact your District Resident Liaison or CATCH staff if you have any questions.

*What is a medical home? A medical home is not a building, house, or hospital, but rather an approach to providing comprehensive primary care. A medical home is defined as primary care that is accessible, continuous, comprehensive, family centered, coordinated, compassionate, and culturally effective. In a medical home, a pediatric clinician works in partnership with the family/patient to assure that all of the medical and nonmedical needs of the patient are met. Through this partnership, the pediatric clinician can help the family/patient access and coordinate specialty care, educational services, out-of-home care, family support, and other public and private community services that are important to the overall health of the child/youth and family. CATCH Resident Funds Application Guidelines

Eligibility and Selection Criteria

Applications are peer-reviewed by the American Academy of Pediatrics (AAP) District CATCH Facilitators (the oversight committee of the CATCH Program), Chapter CATCH Facilitators, District Resident CATCH Liaisons and National Resident CATCH Liaisons.

Applications must demonstrate the following prerequisites:

Only pediatric residents from the United States and its territories are eligible to apply. **Residents are eligible to apply only if you are graduating from residency in or after June 2011 (for most Categorical Pediatrics Residents this would be PGY-1 and PGY-2 residents only).**

- Project includes planning activities or demonstrates prior planning activities.
- Project includes plans for community partnerships. (Examples of community partners include:
 - Businesses in your community
 - Cultural organizations
 - Faith-based groups
 - Governmental and nongovernmental health agencies
 - Grassroots community associations
 - Hospitals
 - Media
 - Parents, grandparents, children, caregivers
 - Public health service agencies
- Budget reflects project timeline and activities.
- Project increases children's access to a medical home or specific health services not otherwise available.
- Methods for measurement of project goals and objectives described.

Priority will be given to proposals that demonstrate the following criteria:

- Project assesses children's medical home status and connects children who previously had none with a medical home.
- Project increases access to needed health services not otherwise available.
- Project predominantly serves a population known to be underserved or with demonstrated health disparities.
- Project assesses children's health insurance status and connects them with available insurance programs.
- Project is feasible and likely to achieve stated goals.
- Community partnerships are broad-based.
- Project is a new initiative within the community.

Application Procedures

- Application must be submitted online at www.aap.org/catch/residentgrants.htm.
- The mentor signature form posted at the above Web page must be submitted as an attachment to your online application.
- Application must be submitted by a pediatric resident.
- Résumés and curricula vitae will not be accepted as a substitute for the narrative biographical sketch requested in the application.
- Attachments: Applicants may submit up to 4 one-page attachments. For example, minutes or agendas from community meetings; flyers; and letters of support, especially from AAP state chapters and current or future community partners. Each attachment must include the applicant's full name. **Attachments may not be used to respond to or supplement questions contained within the application.**
 - One of these 4 attachments should be a letter of support from your mentor.
- Please note that your responses to the survey questions contained within the application will not affect your scores or influence funding decisions.

Guidelines for Developing Your Application, Timeline and Budget

Activities may include needs assessments, community asset mapping, feasibility studies, community meetings, focus groups, and development of grant proposals for implementation and sustainability beyond the grant period. Implementation activities (if included in the proposal) may, in the context of a pilot project, include service delivery, outreach, and promotion.

Research projects

Physicians' or dentists' salaries or fees
Indirect costs/administrative overhead/fiscal agent fees/fringe benefits
Internal Review Board (IRB) preparation/submission
Supplemental funding to previously awarded grants
Supplemental funding for existing program activities
Building or office construction and related activities
Capital equipment
Computer hardware and software
Medical equipment or supplies (exception: select supplies for oral health projects)
Web site design or construction
Health fairs
Research projects or literature reviews
Professional development (educational or training activities)
Conference registration fees/support
Procurement of materials for resident or medical student education
Purchase of cellular telephones

Guidelines for Developing Your Budget

1. Budget must clearly support the goals and timeline outlined in your application.
2. Budget must include a complete description of each activity.
3. All budget line items must include a formula.
4. Do not group multiple activities in one line item.

To avoid the possibility of personal tax liability, it will be necessary for you to appoint a tax-exempt fiscal agent once you receive your award notification. Per federal tax law, individuals are responsible for the taxes on unexpended funds at year-end. Individuals are also responsible for the taxes on expended funds for which an expense report has not been submitted at year-end.

Deadline for Submission

All applications must be submitted by 2:00 pm central time, January 29, 2010.

Only online submissions will be accepted.

Applicants will be notified in writing of the outcome of their application review by 6/31/10.

Reporting Procedures

Grant funds will be disbursed in two equal installments. Documentation of expenditures will be required before release of the second installment. A final report will be due 90 days after the 6-month completion date, or extended completion date. Up to two 6-month extensions are allowed. The first installment must be requested within 3 months of the award notification.
