

# ACA 2013-2014 MEDICAID PAYMENT INCREASE STATE DOCUMENTS

The following are state ACA 2013-2014 Medicaid payment increase notices, self-attestation forms, and other documents that have been released as of November 21, 2013. Please visit these forms and follow your state's instructions for self-attesting eligibility for the ACA Medicaid payment increase to your state. Of note, not all states have released self-attestation forms to date. If your state is not represented on this chart, contact your state AAP chapter's executive director or speak to your state Medicaid office to learn of your state's plans for implementing the payment increase and instructions as to signing up. Payment at increased rates for those self-attesting begins with date of self-attestation after January 1, 2013.
Tennessee	<a href="#">Notification (scroll down)</a>	TennCare managed care organizations (MCO) will be sending eligible physicians notifications in coming weeks indicating that they do not need to self attest for the payment increase if their credentialing information is on file with the MCO, unless they supervise nonphysician clinicians who they also want to receive the increase, in which case they must self-attest. Physicians without proof of certification on file with MCOs will need to attest as well. More information is pending from the	Retroactive to 1/1/13.

# ACA 2013-2014 MEDICAID PAYMENT INCREASE STATE DOCUMENTS

Eligible providers who submit their attestation form and are either board certified or meet the 60% threshold by 12/14/12 will receive enhanced payments starting 1/1/2013. Providers who submit their attestation after 12/14/12 but before 3/1/13 will receive enhanced payments starting in the second quarter of 2013 along with retrospective adjustments to prior payments. The Department of Vermont Health Access will make a determination during Q1 of 2013 as to whether additional attestations will be accepted.
